Harold A. Stein, MD, FRCSC* Prize for Best Scientific Paper Application

The Harold A. Stein, MD, FRCSC* Prize for Best Scientific Paper Application is awarded to an Allied Ophthalmic Personnel (AOP) who demonstrates exemplary research and authorship. Harold A. Stein, MD, FRCSC, was President of IJCAHPO from 1986 to 1987, and was the author of numerous publications, including the ever popular "Ophthalmic Assistant/A Text for Allied & Associated Ophthalmic Personnel" now in its 11th edition.

Original, unpublished research or work will be accepted. The work may include a case study, case study review, or research article on clinical or related topics. The author must give methods and the document should contain an introduction, conclusion, and references. Topics include, but are not limited to, 3D Vision; Computers & Vision; Effect of Systemic Disease on Vision; Effect of Ocular Disease on Vision; Vision of Great Artists; Vision of Animals and/or Birds; Space Vision; Cataracts; Contact Lenses; Dry Eye; Glaucoma, Macular Degeneration.

To perpetuate the prize, Dr. Stein donated royalties from specific books he authored to the JCAHPO Education and Research Foundation. Dr. Stein passed away in 2021.

All applicants will be informed of the status of their submission by September 1.

Applications must be submitted electronically in PDF format no later than June 30.

Eligibility:

Only one (1) entry per candidate is permitted in any year. If the entry does not win, it may be resubmitted the following year if it has NOT been published.

Recipients may receive the Harold A. Stein, MD, FRCSC, Prize one time in a three (3) year cycle. Previous recipients of IJCAHPO or ATPO Continuing Education and/or Certification grants are not eligible to submit a scientific paper until three full years after receipt of the scholarship or grant. Members of the Selection Committee and IJCAHPO staff are ineligible to submit scientific papers.

Prize will be awarded at the Harold A. Stein, MD Lecture during IJCAHPO's Annual Continuing Education Program. It is the responsibility of the winner to arrange for attendance at the program.

All certified or non-certified clinical Allied Ophthalmic Personnel (AOP) in the U.S. and Canada are eligible to submit papers.

Guidelines for Paper:

Typed, double-spaced

In addition to the research paper, please include a cover page, references/bibliography, and diagrams. There is no page limit and papers will be evaluated on content not length of the submission.

The paper must be based on Research, Scientific Content, Originality, and written with APA Style Guide guidelines.

Preferred format: PDF

Selection Criteria:

Presentation will be selected based on research of topic, scientific content, and originality.

Selection of recipients is accomplished by a Selection Committee.

The applicant's age, sex, religion, or race shall not be considered.

Winning papers are the property of the author, who will state in published material the wording, "Winner of the [year] Harold A. Stein, MD, FRCSC, Prize for Best Scientific Paper, JCAHPO Education and Research Foundation."
