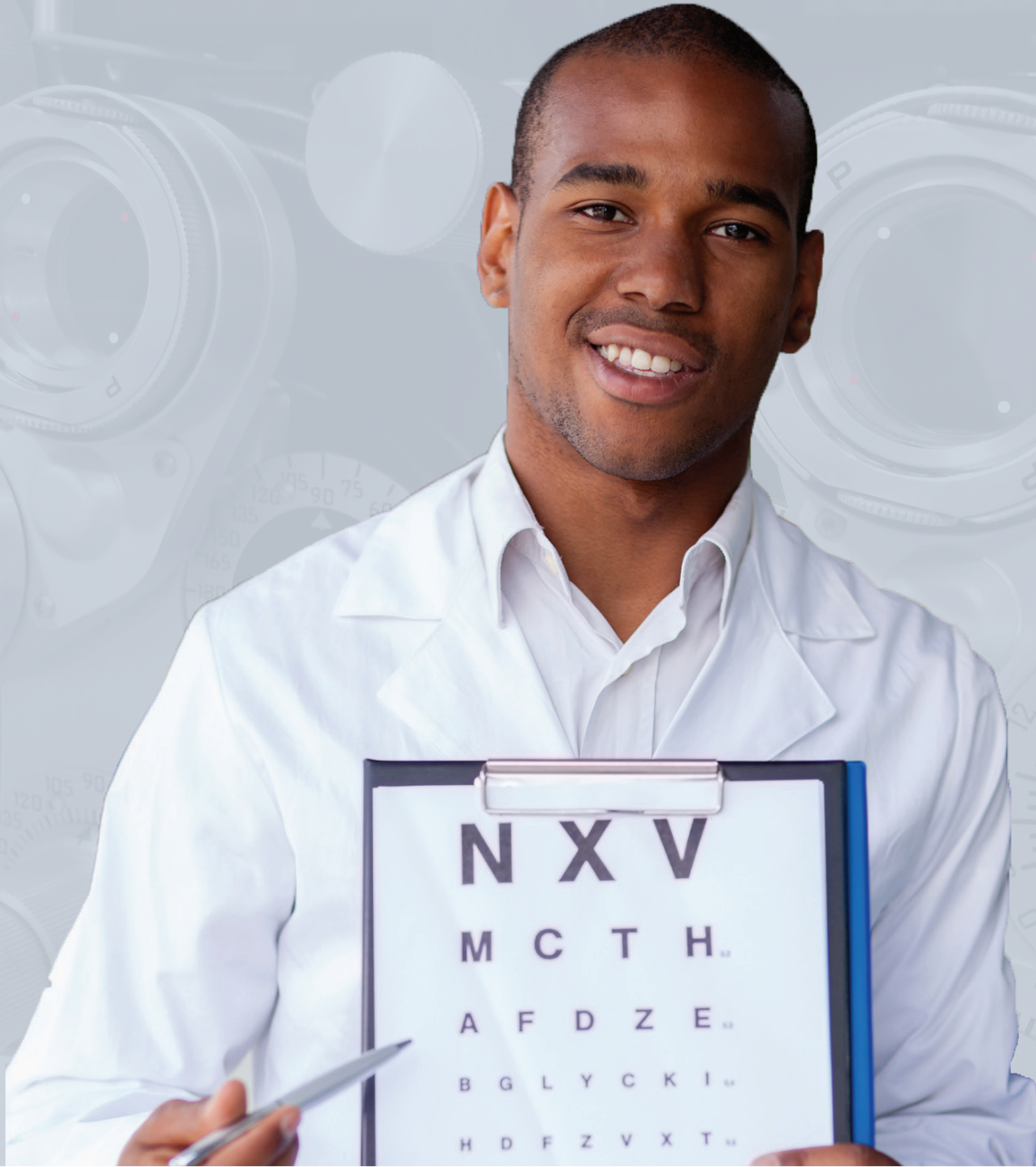

- 12:30-1:30 p.m. **MULTIPLE MODALITIES CASE PRESENTATION** • Craig Simms, BSc, COMT, ROUB, CDOS
This course will present cases where the patient underwent multiple different testing modalities. The focus of this course will be on how the different modalities correlate and how they help the ophthalmologist come to a conclusion. Cases presented will include ultrasound, imaging, photography, visual field testing, and electrophysiology.
- 1:30-2:30 p.m. **YOU CAN LEARN A LOT FROM A PUPIL** • Steven Newman, MD
Examining the pupil gives information from both the afferent and efferent visual pathways. It is important to emphasize the three pupil questions: are they regular, are they equal, and do they react normally? Careful examination of the pupil is often within the purview of the technician since in many ophthalmology offices, the patients are dilated before the physician sees them. It is imperative that technicians be aware of their importance in detecting abnormal pupillary reactivity, anisocoria, and irregular pupils. We will show some examples of both afferent and efferent visual pathology that affect the pupil and how it should be detected.

We will discuss those advancements and how we can best serve our patients to ensure their surgery is a success.
- 11:15 a.m.-12:15 p.m. **MEDICOLEGAL ISSUES OF THE EHR** • Robert Wiggins, MD, MHA
EHRs are changing the landscape of malpractice litigation. Whereas they may reduce the risks of malpractice litigation in some cases, they also introduce new risks which may increase the risk of professional liability. This course explores those risks and how they may be mitigated and reduce a potential source for patient harm.

- 1:15-2:15 p.m. **REFRACTOMETRY** • Craig Simms, BSc, COMT, ROUB, CDOS
This course will cover plus cylinder retinoscopy and refractometry. The optics behind the principles of plus cylinder retinoscopy will be covered followed by graphical examples of the procedures. The course will then move to the refinement part of the process showing methods utilizing the Jackson cross cylinder. The course will conclude with completing the refractometry procedure with reading add, balancing techniques, and the duochrome test.
- 2:15-3:15 p.m. **EVALUATING THE EYELID PATIENT: DROOPS, BUMPS, AND LUMPS** • Kian Eftekhari, MD
This course will give a high-level background on how to evaluate patients who complain of droopy eyelids. In addition, we will review common eyelid lesions.
- 3:15-4:15 p.m. **THE TEARING PATIENT: PRACTICAL PEARLS AND SURGICAL DECISION MAKING** •
Kian Eftekhari, MD
This course will help in the workup of patients with tearing. It will also describe factors that go into what kinds of surgery may be performed for patients with a blocked tear duct.
