

Evisceration, enucleation, and exenteration are procedures that involve removal of all or part of the eye and/or orbit. The purpose of this lecture is to review the indications for and the differences between each of these procedures. Pre-operative and post-operative issues will also be discussed. 10:15 - 11:15 a.m. CURRENT CONCEPTS IN THYROID EYE DISEASE • Richard Allen, MD, PhD, FACS

Thyroid eye disease is an inflammation of the orbit usually associated with a history of an underlying thyroid abnormality. The course of the disease may be mild, moderate, or severe. Ocular complications of the disease include exposure keratopathy, proptosis, strabismus, and compressive optic neuropathy. This course will review the work-up of a patient with thyroid eye disease and the current medical and surgical treatments available.

In this course, attendees will learn how to describe visual fields in neuro-ophthalmology, and in particular, recognize and localize homonymous hemianopsia and bitemporal hemianopsia.

This course will review the key clinical and radiographic features of five potentially life and vision threatening disorders including: 1) giant cell arteritis, 2) pituitary apoplexy, 3) mucor abscess, 4) posterior communicating artery aneurysm, and 5) cartoid or vertebral artery dissection.
