#### Ontario Laws About ROUB and CDOS Certification

IJCAHPO Board Member, Carla Blackburn, BSc, COMT, CDOS, ROUB highlighted an announcement pertaining to ophthalmic ultrasound. Accreditation Canada, diagnostic standard for ophthalmic ultrasound, states that ultrasonographers must hold appropriate qualifications and IJCAHPO's two credentials are listed as acceptable. This recognition highlights the importance of the Registered Ophthalmic Ultrasound Biometrist (ROUB), the Certified Diagnostic Ophthalmic Sonographer (CDOS), and the ophthalmic technician's role in eye care.

## **University of Mississippi Medical Center**

The University of Mississippi Medical Center Clinic, Department of Ophthalmology, is a multispecialty academic clinic with all sub-specialties of ophthalmology, including Comprehensive, Glaucoma, Cornea, Retina, Pediatrics, Ocular-Plastics, Neuro-Ophthalmology, and an Optical Shop. Dr. Kimberly Crowder is the chairperson of our department. We began the year with six COAs and now have a total of 31 Certified Ophthalmic Assistants. Two of which also obtained their Ophthalmic Surgical Assistant through IJCAHPO.

The educational journey began several years ago when we offered IJCAHPO CE credits at our annual conference that is attended by our techs as well as other ophthalmic techs throughout the region. We applied and achieved accredited recognition by IJCAHPO for the conference. We then required our techs' attendance in preparation for their certification. Each year, they could earn as many as 7.5 CE credits at this all-day seminar totaling the required hours to maintain their certification every three years. In addition to the conference, we offered courses with accomplished speakers to educate and engage employees provoking their knowledge and skill set. Simultaneously, I worked with each of them ensuring they had the educational literature and the experience they needed to sit for the proctored exam. This led to the success of our team.

"I am so proud of our team and impressed with this tremendous accomplishment. The result of this new level of education and certification among our techs, now 'COAs', is evident daily in their patient interactions. Excellent ophthalmic patient care can only happen when every member of the team is educated, certified, and engaged. Our COAs rose to this challenge, and we are now a stronger team because of their hard work. I appreciate Bobbie's leadership and encouragement in making this goal for our department a reality."

## **New Exam Delivery**

Starting August 1, 2025, select examinations will be offered as proctored online examinations. Online proctoring allows you to take examinations in your workplace, a place of your choosing, or the comfort of your home. Examinations will still be offered in Pearson VUE Centers.

## **Certified Retina Technician (CRT)**

A new credential designed specifically for AOP working in a retina practice will be available. This entry-level credential covers content areas in History and Documentation, Visual Assessment, Diagnostic Ultrasound, Ophthalmic Imaging, and others. Watch our website in the next few weeks to apply.

## Core Certification (COA, COT, COMT) Updates

All three core certifications recently underwent an extensive study, a Job Task Analysis (JTA), to determine the current content areas and tasks that technicians must perform. Each examination has updated domain percentages. Only minor changes in the content areas resulted. While one major change is being implemented, the change does not impact

revising the content: Diagnostic Ultrasound was separated from Biometry; and Ophthalmic Imaging and Photography and Videography have been combined into a single content area. These new changes will take effect August 1, 2025.



Physician–Patient Relationship: Brought to you by OMIC

## Physician-Patient Relationship: Brought to You by OMIC

Physicians may decide to terminate the physician-patient relationship ("the relationship") due to inappropriate behavior, noncompliance, or nonpayment. Termination should be a last resort, and attempts should be made to rehabilitate the relationship if possible. Relationships can be terminated for any reason as long as it is not discriminatory, there are no contractual obligations with payers, or patients are not in the acute phase of care (e.g., during the post-operative period). There are potential liability exposures and risks of medical board complaints related to patient abandonment if the relationship is not properly terminated. It is recommended that physicians develop a policy and procedure to have a standardized process to navigate these challenges.

#### **RISK RECOMMENDATIONS**

- Establish a policy and procedure to address how you will handle inappropriate behavior, noncompliance, or nonpayment, including the process of terminating care.
- Attempt to rehabilitate the relationship before termination.
- Document the issues and rationale for the termination in the medical record.
- Do not terminate for any discriminatory reasons (disability, race, religion, etc.).
- Do not terminate during the acute phase of care (e.g., 90-day post-op period).
- Review health insurance contracts for guidance and exclusions.
- Communicate with the patient the plan to terminate and address any prescription refills.
- Send the termination letter by certified and regular mail, and include in the letter:
  - The reason for the termination (not required).
  - 30 days of emergency care from date of letter.
  - The urgency of continued treatment and the risks of not obtaining care.
  - How they can obtain medical records.
- Flag the termination in the medical record to prohibit the scheduling of future appointments.
- Contact their health insurance or state medical society for referral options.
